Washington, DC – A new set of extensive recommendations for state and local officials across the country to address the threats of climate change has been released by a national group co-chaired by Norfolk Councilwoman Andria McClellan. In Policy Proposals for Growing a Clean Economy and Protecting Communities, the NewDEAL Forum Climate Change Policy Group provides a guide for building a safer, healthier, and more prosperous future, with a special focus on environmental justice.

The report highlights Norfolk's efforts to deal with increased flooding, calling the city "a bold model for how to live with the water." Among its key strategies around resilience, the report calls for cities to update zoning laws, provide creative funding mechanisms to help property owners finance resiliency improvements, and invest in green infrastructure. Emphasizing the essential role of leadership from outside Washington, the Group's recommendations also urge states and cities to pursue 100 percent clean electricity; ambitious efforts to retrofit and electrify buildings; stronger fuel efficiency standards that end emissions from new trucks and are in line with Obama-era goals of about 54 miles/gallon by 2025; carbon pricing; and ending fossil fuel subsidies.

Overall, the report includes a range of transformative and incremental solutions, drawn from the work of innovative policymakers, as well as input from leading think tanks and members of the private sector. Key strategies to address the impacts of climate change are accompanied by dozens of model programs, laws, and pieces of proposed legislation from across the country.

The group was co-chaired by Councilwoman McClellan, as well as Wisconsin Lieutenant Governor Mandela Barnes, who worked with elected officials across the country, as well as experts from outside government to develop practical solutions for state and local officials to pursue.

"Forward-thinking leaders across the nation, many of whom partner with us as members of the NewDEAL network, along with concerned citizens, have shown that solutions exist to cut emissions and protect against climate change," write Barnes and McClellan in the report. "They have built a blueprint for the kind of climate leadership needed to tackle an immense, planetary problem. This report gathers what they've learned. It pairs policy recommendations with real-life examples and best practices."

Acknowledging the lack of national leadership during the past four years, the report stresses that a "better, safer future isn't just possible — it's already happening in cities and states across America," where "leaders have stepped in to set ambitious clean energy goals, expand solar access to low-income residents, clean up transportation, make polluters pay, and build greener, more energy-efficient cityscapes."

OPED: Charlottesville's extreme weather heralds a greater environmental crisis.

As we endure winter and hope for an early spring, we also know that spring now brings dangerous, heavy rains that are only predicted to grow more frequent.

For decades, scientists have noted that extreme weather could be one the most disastrous impacts of climate change. Now, after years of federal policymakers ignoring the problem, the negative impacts are popping up all over Virginia.

A Community Climate Collaborative report from this summer highlighted the flooding already happening throughout Central Virginia. From 1995 to 2015, Charlottesville and Albemarle County experienced nearly 100 floods, creating more than a million dollars in damage and tragically claiming one life.

Using long-term climate data, the report also showed the average number of extreme rainfall days in Charlottesville has climbed by nearly 80% from the 1890s to 2010s. Without coordinated and real action, this trend will increase as temperatures rise. According to the report's authors, flooding and extreme rain events will be a "top climate hazard for Charlottesville by 2050."

But this problem is not limited to Charlottesville. In Alexandria, entire communities face regular basement flooding despite not living in a flood zone. In Southwest Virginia, the agricultural sector faces inconsistent growing seasons and extreme crop-killing weather. And in Hampton Roads, where I live, families are being priced out of their homes by rising insurance costs, due to repetitive flooding. Flooded, impassable roads to one of the nation's busiest seaports could keep trucks with goods from reaching Central Virginia grocery stores and have a massively negative impact on the economy. A 2006 report from the Mason School of Business found that more than \$31 million in goods passed through the Port of Virginia; this activity generated \$4.5 billion in revenue and more than 35,000 jobs. Since then, the economic power of the Port has only grown, so too has its flood risk.

However, it is not just a matter of economic security; addressing flooding is vital to national security. The world's largest naval base is in Norfolk, and mission-readiness is challenged by flooding, sea level rise and frequent "rain bombs." In Hampton Roads, local leaders and the Navy's top experts have been working hand-in-hand to ensure that this critical national security node is protected and the supported industries, notably shipbuilding, can continue to operate despite flooding and higher tides.

Yet, challenges created by climate change are too great to be overcome by just local and regional action, regardless of the partner. We need better, coordinated policies that address immediate needs and stem the growing crisis of flooding. We need to attack the challenge on all fronts: state and federal policies that address flooding and global agreements to reduce carbon emissions.

As lieutenant governor, I will bring my experience of working on flood and climate mitigation to Richmond. Flooded roads and pricey property damage are proof that we need to move now, because families are already experiencing the impacts of the climate crisis.

At the 35,000-foot level, I will work toward accelerating our goal of a 100% Clean Energy Virginia by 2050. Achieving this goal will not only involve tax incentives and more clean energy generation opportunities, but also scientific breakthroughs, like those developed at the University of Virginia's School of Engineering and the Center for Economic & Policy Studies at the Weldon Cooper Center for Public Service. We need to invest in the development and implementation of these technologies that are innovating the green energy future in Virginia.

However, we don't have to wait for these new technologies. Others, such as offshore wind, are being built now promising clean energy and 5,000 new supply chain jobs. Virginia's mountain ranges also offer wind power opportunities.

Though, as with all issues, state and federal policy are necessary to drive total and lasting change each of us, individually, has the power to make an impact by demanding lawmakers prioritize environmental justice and reducing our own personal carbon footprint, by implementing energy efficiency measures, migrating to electric vehicles, composting and/or installing rooftop solar panels.

Climate change is driving up temperatures and rainfall throughout the commonwealth. We can take steps to address the crisis before flooding grows into something much worse.

- In March 2017, the Roanoke Times reported Delegate Rasoul "said Wednesday he no longer will accept special interest PAC or lobbyist campaign contributions or any donations of more than \$5,000 from individuals or businesses.

# History on Pipelines (MVP and ACP in particular)

- On November 19,2020, Channel 19 of Charlottesville reported that Delegate Rasould had issued a public statement calling for the cancelation of the MVP.
- On July 5, 2020, Delegate posted a Tweet celebrating the cancelation of the ACP, declaring "Never again have a Democrat run pro-pipeline." Followed by the declaration: "Next Step: Stop the Mountain View Pipeline!"
- On February 6, 2018, the <u>Roanoke Times reported</u> Delegate Rasoul introduced several antipipeline bills in the legislature (which all failed). See also next segment below.

- Was co-patron of HB 643, and HB 644, two anti-pipeline bills, in 2020 Legislative Session.(Bills Failed). Also co-patron for HB 646 Pipeline construction permit; amount of civil penalty for violation in 2020 Legislative Session.(Bill Passed)

- Was co-patron for HB 1354 Plastic Waste Prevention Advisory Council in 2020 Legislative Session (Bill Passed)
- Was co-patron for HB 1641 Coal ash ponds; private wells and public water supply wells; resident notification in 2020 Legislative Session (Bill Passed)
